Chapter 1 Introduction

__

1.1 Acknowledgement to Country

The Mid Coast Bush Fire Management Committee (BFMC) acknowledges and pays respect to the Traditional Owners of the lands on which we work, and the lands we travel through. We also acknowledge our Elders – past, present and emerging.

1.2 Introduction

A Bush Fire Risk Management Plan (BFRMP) provides information on the bush fire risks within your community. It also outlines how land managers along with fire authorities are going to effectively manage those risks through implementing various treatment strategies.

The development of a BFRMP is a legal requirement under section 52 of the *Rural Fires Act 1997* (NSW) (the Act). The BFRMP, including the accompanying appendices and spatial data, is prepared by Mid Coast BFMC and is approved by the Bush Fire Coordinating Committee (BFCC).

A BFRMP is a strategic document that identifies community assets and values that may be at risk from bush fire and identifies coordinated multi-agency objectives and associated treatment strategies to reduce the risk over a five year period. Treatment strategies may include such actions as hazard reduction burning, mechanical clearing, targeted community engagement programs and ignition prevention activities. The treatment strategies are implemented by the member agencies / organisation of the BFMC and are monitored and reported on an ongoing basis.

This document (including its appendices) and the accompanying maps form the BFRMP for the Mid Coast BFMC area. It covers both public and private land and is to be reviewed and monitored annually.

This BFRMP is applied in conjunction with the BFMC's Fire Access and Fire Trail (FAFT) Plan and Operations Coordination Plan to provide a comprehensive approach to risk mitigation and operational preparedness.



1.3 Aim and objectives

The aim of this BFRMP is to reduce the risk of adverse impacts of bush fires on life, property, infrastructure and environmental, economic, cultural, agricultural and community assets.

The objectives of this BFRMP are to:

- **Objective 1:** Reduce the number of human-induced bush fire ignitions and their potential to cause damage to life, property, infrastructure and environmental, economic, cultural, agricultural and community assets.
- **Objective 2:** Manage fuel to reduce the rate of spread, intensity and impact of bush fires on life and assets while minimising damage to environmental and cultural values.
- **Objective 3:** Increase the community's resilience to bush fires by improving its preparedness, response and recovery.
- **Objective 4:** Provide advice and strategies to plan, prepare and implement activities to effectively contain fires with the potential to cause damage to life, property, infrastructure and environmental, economic, cultural, agricultural and community assets.

1.4 The Planning Process

The Australia/New Zealand Standard AS/NZS 31000: 2018 Risk Management was used to guide the bush fire risk assessment process. This is outlined in Figure 1 below.



Figure 1: Overview of the risk assessment process



Chapter 2

Risk Assessment

2.1 Assets

An asset is something that is valued by the community. There are four main categories of assets considered in the BFRMP, each with subcategories.

2.1.1 Human settlement

- Residential areas including urban-bushland interface areas and rural properties; and
- Special Fire Protection areas including schools, hospitals, nursing homes, and tourist facilities.

2.1.2 Economic

- Agricultural includes crops, bulk grain storage, grazing, horticulture, intensive animal production, livestock, fencing and major machinery sheds;
- Commercial includes commercial services, Defence facilities, research facilities and ports and water transport;
- Electrical including transmission lines, substations and electricity generation plants;
- Forestry assets native forests, hardwood and softwood plantations;
- Industrial includes general purpose factories, food processing factories, major industrial complexes, abattoirs, oil refineries and sawmills;
- Infrastructure airports, communication towers, roads, railways, waste treatment plants, water treatment plants;
- Mining combustible, non-combustible and underground;
- Recreational community recreation facilities and major sporting and recreation complexes;
 and
- Water catchments.

2.1.3 Environmental

- Threatened Flora and Fauna includes iconic species such as koalas, threatened species, threatened ecological communities (TECs), and threatened populations at risk of extinction in NSW;
- Fire sensitive vegetation communities includes regulated wetlands, RAMSAR wetlands and rainforest vegetation communities;
- Land covered by statutory conservation and biodiversity agreements;
- World Heritage and national and state heritage listed areas;
- Land with geological significance includes land with high erosion potential, or geotechnical risk, karst landscapes and sand dunes;



- Environmentally significant land identified by an Environmental Planning Instrument including Local Environment Plans (LEPs) and State Environmental Planning Polices (SEPPs); and
- Other locally important assets including vegetation identified as bush fire refugia, bush regeneration areas and Assets of Intergenerational Significance (AIS).

Note: not all of these assets have quantitative risk assessment methodologies.

2.1.4 Cultural

- Aboriginal heritage including items recorded in the Aboriginal Heritage Information Management System and predictive site locations from the Aboriginal Sites Decision Support Tool (ASDST);
- Non-Indigenous cultural heritage items and places from the State Heritage Inventory, Section 170 Heritage and Conservation Register and the Historic Heritage Information Management System.

Assets across all four categories have been identified using geographic information system (GIS) data including land use classifications and cadastre (Lot boundaries), as well as local knowledge.

2.2 Neighbourhood Safer Places

A Neighbourhood Safer Place (NSP) is defined by section 62C of the *Rural Fires Act 1997* as "land or a building designated as a neighbourhood safer place". NSPs provide a place of last resort for people during a bush fire. All designated NSP locations for NSW are available at www.rfs.nsw.gov.au.

The Mid Coast BFMC considered the number and location of Neighbourhood Safer Places (NSPs) within the BFMC area. All NSPs in Mid Coast BFMC area require ongoing treatment by the applicable land owner to ensure that the asset remains viable as a place of last resort for people during a bush fire. Therefore, all NSPs within the BFMC area are required to be treated and have been included in the Fuel Management Register.

2.3 Risk Identification and Analysis

This BFRMP is underpinned by a risk quantification methodology based on fire behaviour modelling (Phoenix RapidFire). The fire simulation process applies an ignition model, local historical weather and historical fire information to determine where fires are most likely to occur in the landscape. A Bayesian Decision Network model is used to quantify the bush fire risk to each asset in the landscape based on relevant vulnerability criteria.

Bush fire risks may also be identified during the process from qualitative assessment methodologies. For example where expert local knowledge identifies a significant area of concern, challenges in firefighting or locally significant values.

The risk maps for each asset category are provided in Appendix 3.

Chapter 3

Treating Risk

—

3.1 Treatments

The purpose of risk treatment is to reduce the likelihood and/or harmful consequences of bush fire to the community and environment, through a process of selecting and implementing risk treatment options that modify the characteristics of the hazard, the community or the environment. There are three types of treatments considered in the BFRMP:

- 1. BFMC Wide Treatments;
- 2. Focus Area Treatments; and
- 3. Fuel Management Treatments.

BFMC members and land managers routinely implement risk treatment strategies in accordance with legislative requirements, policy and asset management. For example, vegetation management, restrictions on development in bush fire prone areas, bush fire education and fire suppression activities. We refer to these as BFMC Wide Treatments. These activities occur outside the BFRMP and reduce the bush fire risk to assets and communities throughout the BFMC area.

The risk assessment process applied in this BFRMP assists BFMCs in identifying strategic Fuel Management Treatments and Focus Area Treatments.

Fuel Management Treatments include hazard reduction burns and vegetation clearing. These are designed to protect life, property and the environment from intense bush fires. While they will not completely stop bush fires from starting and spreading, these treatments can help protect firefighters, assist with containment strategies and reduce the potential damage to community assets and environmental values.

Focus Areas are groups of assets in the landscape that the BFMC has identified as having significant or unacceptable risk. The BFMC has specifically identified Focus Area Treatments for these areas and they prioritise these treatments over all others.

3.1.1 BFMC Wide Treatments

BFMC wide treatments are activities which are undertaken to reduce the overall bush fire risk within the BFMC area.

The following table identifies the BFMC wide treatments applicable to the Mid Coast BFMC area.



TREATMENT	DESCRIPTION
IREATMENT	DESCRIPTION
Plan of Operations	Under Part 3 Division 4 Sections 52 and 53 of the <i>Rural Fires Act 1997</i> , BFMCs are required to prepare and submit to the BFCC a Plan of Operations and must review the Plan every two years. The Plan of Operations details the co-ordinated firefighting arrangements and fire management practices and ensures that each BFMC member is able to execute its role and specific responsibilities.
Treatments in the Fire Access and	Under section 52 of the Act, BFMCs must develop a Fire Access and Fire Trail (FAFT) Plan for their area and must review the FAFT Plan every five years.
Fire Trail Plan Treatment Register	Fire trails are an important part of ensuring firefighters can access fires and safely contain them. Fire trails may also be used as fire control lines for hazard reduction burns, however this is not their primary purpose.
	In accordance with the NSW RFS Fire Trail Standards the BFMC may prepare a Treatment Register which sets out a schedule of works for the construction and maintenance of fire trails. The Standards provide that the Treatment Register is updated annually and typically forms part of a FAFT Plan.
	Treatments contained within the FAFT Plan Treatment Register (as amended from time to time) are BFMC Wide Treatments under this BFRMP.
Ignition Prevention Plan	The BFMC will develop an Ignition Prevention Plan (IPP). The purpose of the IPP is to provide firefighting authorities, NSW Police and Local Authorities with localised strategies to prevent ignitions. In particular, deliberate or careless ignitions and illegal fires.
Land & Asset Management	There are organisational plans, standard policies, Regulations and procedures for the management of assets and/or land managed by BFMC members. For example vegetation clearance around power lines, maintenance of public land, and agency-specific fire management plans.
Local Environmental Plans	Local Environmental Plans (LEPs) guide planning decisions for local government areas. They do this through zoning and development controls, which provide a framework for the way land can be used.
	LEPs can be used to exclude development in significant bush fire risk areas or in areas where bush fire protection measures cannot be incorporated.
Environmental Approval for all Hazard Reduction	Land management agencies will obtain environmental approval (through the Bush Fire Environmental Assessment Code, or other approval process) to undertake any activities that have the potential to impact the environment e.g. hazard reduction burning or vegetation removal. The environmental assessment process considers flora, fauna, threatened species, cultural assets, soil erosion, riparian areas, biodiversity fire regimes, weeds and air pollution (smoke).
Bush Fire Prone Land Mapping and	Section 10.3 of the <i>Environmental Planning & Assessment Act 1979</i> requires the land subject to a BFRMP to be mapped in accordance with Guide for Bush Fire Prone Land Mapping. Bush Fire Prone Land Maps are used as a trigger mechanism to ensure that new development is approved in accordance with Planning for Bush Fire Protection (PBP).
Planning for Bush Fire Protection	PBP sets planning specifications which aim to increase the likelihood of structures surviving a bush fire, and in combination with Australian Standard 3959 Building in Bush Fire Prone Areas which specifies building standards.
	All new development on Bush Fire Prone Land will be assessed in accordance with PBP.



Hazard complaints	It is the duty of land owners to prevent the occurrence of bush fires on, and to minimise the danger of the spread of bush fires on or from, their land. Under section 66 of the <i>Rural Fires Act 1997</i> , a Bush Fire Hazard Reduction Notice can be issued, directing a hazard be removed. This Notice can be issued to private and public landowners. If the Bush Fire Hazard Reduction Notice is not complied with, the NSW RFS will remove the hazard, and may pursue the cost from the landowner. Under Section 73 and Section 74E of the Act, the NSW RFS Commissioner may direct hazard reduction works to be undertaken.
Community engagement	This includes state-wide public awareness initiatives as well as local community interactions between fire agencies, land managers and local communities.
BFMC Bush Fire Danger Period	The Rural Fires Act 1997 sets the statutory Bush Fire Danger Period. A Fire Permit is required for burning activities during the Bush Fire Danger Period in Rural Fire districts and at all times in Fire and Rescue (FRNSW) districts around the state. Fire Permits help ensure fire is used safely during the Bush Fire Danger Period. A permit imposes conditions on the way a fire is lit and maintained, and can only be issued by authorised Permit Issuing Officers. The permit provides landholders who intend to burn, with the conditions they are to adhere with to ensure adequate and appropriate measures are in place, and that fires remain under control.
Firefighting response	All firefighting authorities in NSW have legislation, regulations, policies and procedures for responding to bush fire events within their area of jurisdiction.
Prosecution of arsonists / offenders	Under the Rural Fires Act 1997 persons may be prosecuted for a range of offences. These offences include: deliberately setting fire to the land of another person without consent; lighting a fire without notifying the relevant authority; breaching the conditions on a fire permit; lighting a fire during a Total Fire Ban; allowing fire to escape their property; or other breaches of the Act.

3.1.2 Fuel Management Treatments

Hazard reduction is an important component of managing bush fire risk. Hazard reduction involves removing or reducing the fuel (vegetation) in order to modify the potential fire behaviour, to reduce extreme bush fire behaviour and associated impact to firefighters and to community assets and values, to assist in fire suppression and to enable appropriate fire regimes to be implemented.

The BFRMP Fuel Management Register is a list of hazard reduction activities that the Mid Coast BFMC has identified as strategic treatments in the BFRMP. The fuel management treatments include prescribed burns, vegetation removal in BFMC-managed asset protection zones and the development or maintenance of fire breaks.

All hazard reduction activities listed in the Fuel Management Register are proposed to be completed within the five-year term of BFRMP, however, those activities that are linked to a Focus Area will be treated as a priority. The occurrence of bush fires will necessitate annual revision and reprioritisation of the treatment schedules.

See Appendix 2 for the Mid Coast BFMC Fuel Management Register.

3.1.3 Focus Area Treatments

The management of bush fire risks involves a coordinated approach from fire authorities, landowners, land managers, planning authorities, local councils and the community. Even with the combined resources of these stakeholders, it is still not possible or practical to actively treat all bush fire risks across the landscape. It is therefore important for communities and BFMCs to determine what areas will form the focus for the application of specific treatment strategies in this BFRMP.

Focus Areas were determined through an analysis of the quantitative risk assessment data, but also consider factors such as the social vulnerability of the community, access and egress and local significance.

There are twelve Focus Areas within the Mid Coast BFRMP. These are:

- North Shore:
- Queens Lake/Lake Innes Koala Environmental Focus Area;
- Camden Haven;
- Wauchope;
- Green Point;
- Coomba Park:
- Smiths Lake / Seal Rocks;
- Myall Lakes NP Ramsar;
- Bulahdelah / Markwell;
- Tea Gardens / Pindimar;
- Werrikimbe NP Environmental Focus Area; and
- Barrington Tops NP Environmental Focus Area.



These are areas that have been specifically identified as having an unacceptable risk and require additional, targeted treatment strategies within the five-year BFRMP.

There are four key objectives available to manage the bush fire risk to Focus Areas and each objective has a number of associated treatment strategies (Table 2). The BFMC has identified the most appropriate objectives and treatment strategies for each Focus Area. The Focus Area treatment strategies selected by the BFMC will be addressed annually as part of the BFMC Annual Works Program.

3.2 Bush Fire Management Zones

Bush Fire Management Zones identified within the Mid Coast BFMC area have been mapped as part of the Fuel Management Register. These zones identify the fire management intent for a specific area. The five categories of Bush Fire Management Zones are:

- Asset Protection Zone (APZ);
- Strategic Fire Advantage Zone (SFAZ);
- Ignition Management Zone (IMZ)
- Land Management Zone (LMZ); and
- Fire Exclusion Zone (FEZ).

See Annexure C BFRMP Guidelines of BFCC Policy 01/2023 for further information on Bush Fire Management Zones including a description of the zones and their purposes.

3.3 Relationship with other Plans

Under section 52 of the *Rural Fires Act 1997*, each BFMC must prepare and submit to the Bush Fire Coordinating Committee a draft of each of the following:

- A bush fire management plan (defined to be both a BFRMP and a fire access and fire treatment plan (FAFT Plan); and
- A Plan of Operations.

These BFMC planning documents should complement each other, however, a FAFT Plan prevails over the BFRMP to the extent of any inconsistency in accordance with section 59A(4) of the Act.

Treatments contained within the FAFT Plan Treatment Register (as amended from time to time) are BFMC Wide Treatments under this BFRMP.

Additionally, an Ignition Prevention Plan will be prepared for the BFMC. Other plans such as Community Protection Plans, agency specific Fire Management Strategies, or private property fire plans may be prepared, however as this BFRMP has been prepared in accordance with the Act, all other plans are subordinate to it.



Chapter 4

Communication and Consultation

4.1 Communication and Consultation

Community participation is an integral part of risk management. The BFMC undertook consultation with the community during the development phase of the BFRMP as outlined in Appendix 4. The Communication Strategy involved developing and implementing a process to address the needs, issues and concerns of stakeholders within the BFMC area in regards to the BFRMP. This involved member agencies engaging with their stakeholders to ensure their views are represented in the BFRMP and that they understand their own responsibility in risk management.

In accordance with section 57 of the *Rural Fires Act 1997*, the draft BFRMP was placed on public exhibition to provide an opportunity for the community to have formal input, and that input has been taken into account and reflected in the BFRMP.

This plan will be available from the RFS web site and must also be available for public inspection at, and be able to be obtained free of charge from, the office of the local authority for the area to which it relates during ordinary office hours.



Chapter 5

Performance Monitoring and Review

5.1 Monitoring and Review

This BFRMP must be reviewed and updated within each successive five-year period from the constitution of the BFMC. The Mid Coast BFMC will also review this BFRMP as necessary to account for any changes in context or risk on account of changes to the BFMC area, organisational responsibilities or legislation; changes to the bush fire risk in the area; changes to the Treatment Register; or following a major fire event.

The BFMC is required to monitor progress towards the completion of treatment works listed in the BFRMP, and the timeliness of the works. This is done through an Annual Works Program and also an Annual Report. The BFRMP may also be audited at the request of the NSW RFS Commissioner or the BFCC.



1.1 North Shore

Risk Profile North Shore

The Mid Coast Bush Fire Management Committee (BFMC) has assessed the risk to residential, special fire protection (schools, health facilities, childcare etc.), economic, environmental and cultural assets and has identified North Shore as a Focus Area.

North Shore and Riverside are isolated communities in the Port Macquarie-Hastings Local Government Area and have a population of approximately 380. The Focus Area includes the declared wilderness area of Limeburners Creek National Park to the north.

The area has a history of bush fire ignition and significant potential for rapid fire development, particularly from the adjacent forested and heath vegetation. The last significant bush fire was in 2017.

A number of residential homes and properties have been identified in the moderate risk category. There are also economic assets (commercial) in the moderate risk category.

Access and egress for residents is limited as the focus area is bounded by waterways accessible by ferry with the Hibbard and Settlement Ferries over the Hastings River to the south and Crescent Head Rd (Kempsey) to the north.

Social and demographic factors such as education, unemployment, isolation and population age may also contribute to the vulnerability of the North Shore and Riverside communities to the impacts of bush fire.

Bush fire is a key threatening process for many environmental assets. There is a risk that a high severity bush fire event in this area would cause serious damage or irreversible loss of habitat for the Koala (*Phascolarctos cinereus*), the critically endangered Beach Stone-curlew (*Esacus magnrostris*) and Native Guava (*Rhodomyrtus psidioides*).

Areas of Regional Koala Significance (ARKS) also exist in the Focus Area. There is also a risk that a bush fire could negatively impact a further eight Threatened Ecological Communities, thirty nine species of threatened fauna, five species of threatened flora, coastal wetland ecosystems and Littoral Rainforest.

There are six known Aboriginal Sites and two known historic sites within the focus area that may also be threatened by bush fire.

A key BFMC objective in North Shore is to improve Community Preparedness. In particular, the maintenance of private property Asset Protection Zones & the preparation of Bush Fire Survival Plans. This will be achieved through the provision of resources such as targeted Prepare Act Survive and bush fire survival plan advertising; the implementation of programs such as AIDER property inspections and engagement at local events. These activities will aim to increase community preparedness for planning, preparation and community resilience for bush fire.



Risk Profile North Shore (continued)

As identified in the Fuel Management Register, the BFMC will maintain Asset Protection Zones and implement prescribed burning hazard reductions to achieve different fire management objectives including ignition management, strategic fire protection and land and biodiversity management.

The BFMC will address the high number of deliberate and accidental bush fire ignitions with specific strategies in the BFMC Ignition Prevention Plan.

To increase resilience within the Focus Area the BFMC will identify specific operational response strategies for the assets/ areas of concern. The BFMC fire access and fire trail network will be reviewed and maintained.

The key Bush Fire Risk Management Plan Objectives and Treatment Strategies for North Shore are listed in Table 1.

1.2 Queens Lake/Lake Innes Koala Environmental Focus Area

Risk Profile • Queens Lake/Lake Innes Koala Environmental Focus Area

The Mid Coast Bush Fire Management Committee (BFMC) has assessed the risk to residential, special fire protection (schools, health facilities, childcare etc.), economic, environmental and cultural assets and has identified the area around Queens Lake and Lake Innes as a Focus Area for environmental reasons.

The area contains national park estate gazetted as an Asset of Intergenerational Significance for koala conservation within Queens Lake Nature Reserve and State Conservation Area, Lake Innes Nature Reserve and State Conservation Area and Innes Ruins Historic Site.

The area surrounding the parks also contains areas of high quality koala habitat and is listed as an Area of Regional Koala Significance. This area is recognised as a key maternity and breeding area within the landscape and an area of high genetic diversity of Koala. There is strong community interest in koala conservation, including a koala hospital that cares for injured koalas.

Bush fire is a key risk to the koala population. There is a risk that a high severity bush fire event in this area would cause serious damage or irreversible loss of regional significant habitat for the Koala and other environmental assets.

Fire events, suppression operations and/or hazard reduction activities could negatively impact the structure and composition of twelve Threatened Ecological Communities as well as the habitat and lifestyle processes for threatened fauna and flora, including the critically endangered Beach Stone-curlew, *Esacus magnrostris*, Native Guava, *Rhodomyrtus psidioies* and Scrub Turpentine, *Rhodamnia rubescens*.

Within the Focus Area. two sites are currently declared Assets of as Intergenerational Significance (AIS) for the Koala, and three areas of Regional Koala Significance (ARKS) also exist in the Focus Area. There is potential for additional AIS declarations in the future and NPWS or the AIS website should be referenced for updates during the life of this risk plan.

A key BFMC objective in managing koalas in this area is an integrated approach encompassing fuel management, ignition management, community preparedness and response treatments to prevent high intensity bush fire impacting the koala population.

Fuel management strategies such as prescribed burning hazard reductions for the reserves within the area will continue to be implemented to provide strategic fire protection and land and biodiversity management outcomes in accordance with the 'Considering koalas in planned burns: Guidelines to reduce the impacts of planned burns on Koala populations' document produced by NSW DPE.

The key Bush Fire Risk Management Plan Objectives and Treatment Strategies for the Queens Lake/Lake Innes Koala Environmental Focus Area are listed in Table 2.

1.3 Camden Haven

Risk Profile Camden Haven

The Mid Coast Bush Fire Management Committee (BFMC) has assessed the risk to residential, special fire protection (schools, health facilities, childcare and tourist accommodation), economic, environmental and cultural assets and has identified Camden Haven as a Focus Area.

This includes areas in and around Kendall, Kew, Laurieton, North Haven, Lakewood, Bobs Creek, Bonny Hills, Dunbogan and Diamond Head. The area has a history of deliberate and accidental bush fire ignition and significant potential for rapid fire development, particularly from the adjacent heath vegetation. Significant bush fires have affected the Focus Area over the last ten years, particularly in 2014, 2018 and 2019.

A number of residential homes and properties have been identified in the highest risk category. There are also economic assets (tourism and commercial) in the high risk category. Social and demographic factors including seasonal tourism, unoccupied dwellings, a high number of special fire protection facilities and retirement-age populations may make the communities of Camden Haven Focus Area more vulnerable to the impacts of bush fire.

Bush fire is a key threatening process for many environmental assets. There is a risk that a high severity bush fire event in this area would cause serious damage or irreversible loss of habitat for the Koala (*Phascolarctos cinereus*), the critically endangered Beach Stone-curlew (*Phascolarctos cinereus*), Native Guava (*Rhodomyrtus psidioides*) and the Scrub Turpentine (*Rhodamnia rubescens*).

There is also a risk that a bush fire could negatively impact twelve Threatened Ecological Communities, sixty five species of threatened fauna, eighteen species of threatened flora, coastal wetland ecosystems and Littoral Rainforest. The Koala is a significant species in this area - two sites are declared as Assets of Intergenerational Significance (AIS) for the Koala and three areas of Regional Koala Significance (ARKS) also exist in the focus area. Cultural values include seventy eight Aboriginal sites, two sites of state heritage significance (Laurieton and Kendall School of Arts) and twenty eight historic heritage sites have also been identified within this focus area.

There is a risk that bush fires, fire suppression operations and hazard reduction strategies could negatively impact ten Save our Species (SoS) program sites and cause negative outcomes for threatened species conservation.

A key BFMC objective in Camden Haven is to improve Community Preparedness. In particular, the maintenance of private property Asset Protection Zones & the preparation of bush fire survival plans. This will be achieved through the provision of resources for street meetings, engagement at local events, supporting community-led initiatives and the implementation of programs such as community protection planning. These activities will aim to increase community preparedness through building community resilience for bush fire.



Risk Profile Camden Haven (continued)

As identified in the Fuel Management Register, the BFMC will maintain Asset Protection Zones and implement prescribed burning hazard reductions to achieve different fire management objectives including strategic fire protection and land and biodiversity management.

The BFMC will address the high number of deliberate and accidental bush fire ignitions with specific strategies in the BFMC Ignition Prevention Plan.

To increase resilience within the Focus Area the BFMC will identify specific operational response strategies for the assets/ areas of concern. The BFMC fire access and fire trail network will be reviewed and maintained.

The key Bush Fire Risk Management Plan Objectives and Treatment Strategies for Camden Haven are listed in Table 3.

1.4 Wauchope

Risk Profile Wauchope

The Mid Coast Bush Fire Management Committee (BFMC) has assessed the risk to residential, special fire protection (schools, health facilities, childcare etc.), economic, environmental and cultural assets and has identified Wauchope as a Focus Area.

Wauchope is a town in the Port Macquarie-Hastings local government area with a population over 13,000. Wauchope is situated on the Hastings River and the Oxley Highway approximately 20km west of Port Macquarie.

Surrounding areas included in this Focus Area are King Creek, Sancrox, Redbank, Yippin Creek, Rosewood and Bago which include forested and open farmland areas.

The area has a history of deliberate and accidental bush fire ignition and significant potential for rapid fire development, particularly from the adjacent forested vegetation. There have been significant bush fires in the area in 2009, 2012, 2017 and 2019.

A number of residential homes and properties have been identified in the high risk category. There are also economic assets (forestry, commercial) in the high risk category. Social and demographic factors including education, unemployment and population age may contribute to the vulnerability of the communities to the impacts of bush fire in this area.

Bush fire is a key threatening process for many environmental assets. There is a risk that a high severity bush fire event in this area would cause serious damage or irreversible loss of habitat for the Koala (*Phascolarctos cinereus*), the critically endangered Native Guava (*Rhodomyrtus psidioides*) and the Scrub Turpentine (*Rhodamnia rubescens*). There is also a risk that a bush fire could negatively impact a further nine Threatened Ecological Communities, fifty eight species of threatened fauna, twelve species of threatened flora, a site of intergenerational significance and the cultural value of the sixty nine Aboriginal sites, one site of state heritage significance (Wauchope Railway Station) and twenty four historic heritage sites that been identified within this focus area.

There is a risk that bush fires, fire suppression operations and hazard reduction strategies could negatively impact one Save our Species (SoS) program sites and cause negative outcomes for threatened species conservation. There is one site declared an Asset of Intergenerational Significance (AIS) for the Koala and an area of Regional Koala Significance (ARKS) also exist in the focus area.

A key BFMC objective in Wauchope is to improve Community Preparedness. In particular, activities that aim to increase and improve the community's awareness and understanding of bush fire risk. This will be achieved through the provision of resources such as prepare act survive advertising, engagement at local events and the implementation of programs such as community meetings and school visits that aim to increase community preparedness and risk awareness for bush fire.



Risk Profile Wauchope (continued)

As identified in the Fuel Management Register, the BFMC will maintain Asset Protection Zones and implement prescribed burning hazard reductions to achieve different fire management objectives including ignition management, strategic fire protection and land and biodiversity management.

The BFMC will address the high number of deliberate and accidental bush fire ignitions with specific strategies in the BFMC Ignition Prevention Plan.

To increase resilience within the Focus Area the BFMC will identify specific operational response strategies for the assets/ areas of concern. The BFMC fire access and fire trail network will be reviewed and maintained.

1.5 Green Point

Risk Profile Green Point

The Mid Coast Bush Fire Management Committee (BFMC) has assessed the risk to residential, special fire protection (schools, health facilities, childcare and tourist accommodation), economic, environmental and cultural assets and has identified Green Point as a Focus Area.

Green Point is a small community located on the east side of Wallis Lake in the local government area of Mid Coast. The Focus Area also includes Forster and Booti Booti National park.

The area has a history of deliberate and accidental bush fire ignition and significant potential for rapid fire development, particularly from the adjacent heath vegetation. Significant bush fires occurred in the area during 2013 and 2019.

A number of residential homes and properties and economic assets (tourism, commercial) have been identified in the moderate risk category. There are also social and demographic factors including ageing population, unoccupied dwellings and new residents that may make the community more vulnerable to the impacts of bush fire. Green Point is located on a narrow peninsula and access and egress for residents is limited via the Forster-Tuncurry bridge and The Lakes Way through Booti Booti National Park.

Bush fire is a key threatening process for many environmental assets in this area. There is a risk that a high severity bush fire event in this area would cause serious damage or irreversible loss of habitat for the Native Guava (*Rhodomyrtus psidioides*) and the Scrub Turpentine (*Rhodamnia rubescens*). There is also a risk that a bush fire could negatively impact a further twelve Threatened Ecological Communities, thirty seven species of threatened fauna, ten species of threatened flora, coastal wetlands ecosystems, Littoral rainforest, the cultural value of the forty five Aboriginal sites, and ten historic heritage sites that have been identified within this focus area.

There is a risk that bush fires, fire suppression operations and hazard reduction strategies could negatively impact six Save our Species (SoS) program sites and cause negative outcomes for threatened species conservation.

A key BFMC objective in Green Point is to improve Community Preparedness. In particular, the maintenance of private property Asset Protection Zones & the preparation of bush fire survival plans. This will be achieved through the provision of resources such as targeted advertising campaigns for tourists, Prepare Act and Survive and bush fire survival plan advertising and the implementation of programs such as street meetings and engagement at local events. These activities aim to increase community preparedness for planning, preparation and community resilience for bush fire.

As identified in the Fuel Management Register, the BFMC will maintain Asset Protection Zones in conjunction with the other objectives outlined.



Risk Profile Green Point (continued)

The BFMC will address the high number of deliberate and accidental bush fire ignitions with specific strategies in the BFMC Ignition Prevention Plan.

To increase resilience within the Focus Area the BFMC will identify specific operational response strategies for the assets/ areas of concern. The BFMC fire access and fire trail network will be reviewed and maintained.

The key Bush Fire Risk Management Plan Objectives and Treatment Strategies for Green Point are listed in Table 5.

1.6 Coomba Park

Risk Profile Coomba Park

The Mid Coast Bush Fire Management Committee (BFMC) has assessed the risk to residential, special fire protection (schools, health facilities, childcare etc.), economic, environmental and cultural assets and has identified Coomba Park as a Focus Area.

Coomba Park, Coomba Bay, Wallingat and Shallow Bay are isolated communities located on the western side of Wallis Lake and is in the Mid Coast local government area. The focus area has a population of approximately 700 residents. The locality is a desirable holiday destination and campgrounds and picnic areas may be occupied by people unfamiliar with the surrounding area and less prepared for bush fire.

The area has a history of bush fire ignition and significant potential for rapid fire development, particularly from the adjacent forested vegetation. The last significant bush fires in the area were in 2012 and 2013.

A number of residential homes, properties and economic assets (tourism and commercial) have been identified in the high risk category. There are also social and demographic factors including education & unemployment, age, and unoccupied dwellings that may make the community more vulnerable to the impacts of bush fire. Access and egress for residents is limited with Shallow Bay Road and Coomba Road the only access out to the Lakes Way and beyond.

Bush fire is a key threatening process for many environmental assets. There is a risk that a high severity bush fire event in this area would cause serious damage or irreversible loss of habitat for the Koala (*Phascolarctos cinereus*) and the critically endangered Scrub Turpentine (*Rhodamnia rubescens*). There is also a risk that a bush fire could negatively impact eleven Threatened Ecological Communities, twenty five species of threatened fauna, one species of threatened flora and coastal wetland ecosystems. The cultural value of the three Aboriginal sites, and three historic heritage sites that been identified within this focus area.

There is a risk that bush fires, fire suppression operations and hazard reduction strategies could negatively impact five Save our Species (SoS) program sites and cause negative outcomes for threatened species conservation.

A key BFMC objective in Coomba Park is to improve Community Preparedness. In particular, the maintenance of private property Asset Protection Zones & the preparation of bush fire survival plans. This will be achieved through the provision of resources such as targeted advertising campaigns for tourists, Prepare Act and Survive and bush fire survival plan advertising, the implementation of programs such as street meetings and engagement at local events that aim to increase community preparedness for planning, preparation and community resilience for bush fire.

As identified in the Fuel Management Register, the BFMC will maintain Asset Protection Zones and implement prescribed burning hazard reductions to achieve strategic fire protection.



Risk Profile Coomba Park (continued)

The BFMC will address the high number of deliberate and accidental bush fire ignitions with specific strategies in the BFMC Ignition Prevention Plan.

To increase resilience within the Focus Area the BFMC will identify specific operational response strategies for the assets/ areas of concern. The BFMC fire access and fire trail network will be reviewed and maintained.

The key Bush Fire Risk Management Plan Objectives and Treatment Strategies for Coomba Park are listed in Table 6.

1.7 Smiths Lake / Seal Rocks

Risk Profile Smiths Lake / Seal Rocks

The Mid Coast Bush Fire Management Committee (BFMC) has assessed the risk to residential, special fire protection (schools, health facilities, childcare and tourist accommodation), economic, environmental and cultural assets and has identified Smiths Lake / Seal Rocks as a Focus Area.

The area has a history of deliberate and accidental bush fire ignition and significant potential for rapid fire development, particularly from the adjacent forested and heathland vegetation. The last significant bush fire was in 2021.

A number of residential homes and properties have been identified in the high risk category. There are also economic assets (tourism and commercial) in the high risk category. There are also social and demographic factors population growth, age, unoccupied dwellings, tourism that may make the community more vulnerable to the impacts of bush fire. Access and egress for residents is limited with Seal Rocks Road and the Lakes Way being the only main roads in and out of the area.

Bush fire is a key threatening process for many environmental assets. There is a risk that a high severity bush fire event in this area would cause serious damage or irreversible loss of habitat for the Koala (*Phascolarctos cinereus*) and the critically endangered Beach Stone-curlew (*Esacus magnrostris*). There is also a risk that a bush fire could negatively impact sixteen Threatened Ecological Communities, thirty eight species of threatened fauna, nine species of threatened flora of threatened flora including two critically Endangered species of Native Guava (*Rhodomyrtus psidioides*) and Scrub Turpentine (*Rhodamnia rubescens*), coastal wetland ecosystems and Littoral Rainforest. The cultural value of the twenty two Aboriginal sites, one site of commonwealth heritage significance (Sugarloaf Point Lighthouse) and three historic heritage sites that been identified within this focus area.

There is a risk that bush fires, fire suppression operations and hazard reduction strategies could negatively impact five Save our Species (SoS) program sites and cause negative outcomes for threatened species conservation.

A key BFMC objective for Smiths Lake / Seal Rocks is to improve Community Preparedness. In particular, the maintenance of private property Asset Protection Zones & the preparation of Bush Fire Survival Plans. This will be achieved through the provision of resources such as targeted advertising campaigns for tourists, Prepare Act and Survive and bush fire survival plan advertising, and the implementation of programs such as Community Protection Planning and engagement at local events. These activities will aim to increase risk awareness, planning, preparation and community resilience to the residential and transient community for bush fire.



Risk Profile Smiths Lake / Seal Rocks (continued)

As identified in the Fuel Management Register, the BFMC will maintain Asset Protection Zones and implement prescribed burning hazard reductions to achieve strategic fire protection.

The BFMC will address the high number of deliberate and accidental bush fire ignitions with specific strategies in the BFMC Ignition Prevention Plan. To increase resilience within the Focus Area the BFMC will identify specific operational response strategies for the assets/ areas of concern. The BFMC fire access and fire trail network will be reviewed and maintained.

The key Bush Fire Risk Management Plan Objectives and Treatment Strategies for Smiths Lake / Seal Rocks are listed in Table 7.

1.8 Myall Lakes NP - Ramsar

Risk Profile Myall Lakes NP - Ramsar

The Mid Coast Bush Fire Management Committee (BFMC) has assessed the risk to residential, special fire protection (schools, health facilities, childcare etc.), economic, environmental and cultural assets and has identified the Myall Lakes National Park as a Focus Area.

Since 1999, this internationally recognised wetlands site, has been listed under the Ramsar Convention due to its diverse mosaic of near-natural wetlands, within a relatively unmodified coastal lake system. There are 18 different wetland types with extensive interconnected lake and river systems within the forested wetlands and swamps that fringe the waterways, rocky and sandy shores, and offshore islands off the coastline. This wetland site houses a complex variety of habitats with rich biodiversity, including threatened species and migratory birds protected under international agreements.

The Myall Lakes wetlands also have a high cultural and social value as they occur within the traditional lands of the Worimi Aboriginal people, where the varied wetlands, environments and abundant resources provided an ideal living environment. Evidence of this traditional occupation exists across the landscape, including the Dark Point Aboriginal Place.

The Myall Lakes Ramsar site constitutes one of the few coastal brackish lake systems in NSW which has not been greatly modified by human activities. The site provides habitat for a diverse number of native flora and fauna species, including large numbers of waterbirds such as the Black swan (Cygnus atratus), Eurasian coot (Fulica atra) and Chestnut teal (Anas castenea), and plays an important role in linking key fauna habitats to the north and west and in providing connectivity between estuarine wetland ecosystems to the north and the south.

The lakes in the Ramsar site are part of the coastal lake system in New South Wales which provides drought refuge for waterbirds.

Ramsar wetlands in Australia are 'matters of national environmental significance' protected and managed under national legislation, the *Environment Protection and Biodiversity Conservation Act 1999* and *The Water Act 2007*. By law, any action that has, will have or is likely to have a significant impact on matters of national environmental significance must be referred to the responsible Minister for consideration. Importantly, this Act also aims to protect matters of national environmental significance from impacts even if they originate outside the property.

The World Heritage properties are potentially vulnerable to inappropriate fire regimes including unplanned and intense bush fire events.



Risk Profile Myall Lakes NP – Ramsar (continued)

Bush fire is a key threatening process for many environmental assets. Fire events, suppression operations and/or hazard reduction activities could negatively impact the structure and composition of fifteen Threatened Ecological Communities as well as the habitat and lifestyle processes for threatened fauna and flora, including the critically endangered Native Guava, *Rhodomyrtus psidioies* and Scrub Turpentine, *Rhodamnia rubescens*. Two sites declared as Assets of Intergenerational Significance (AIS) for the Gould's Petrel, *Pterodroma leucoptera leucoptera* and Guthrie's Grevillea, *Grevillea gutherieana*, regionally significant habitat for Koalas, *Phascolarctos cinereus*, and Littoral Rainforests.

There is potential for additional AIS declarations in the future and NPWS or the AIS website should be referenced for updates during the life of the Risk Plan.

A key BFMC objective in Myall Lakes Ramsar Site is to implement an integrated approach encompassing fuel management, ignition management, community preparedness and response treatments. The fire management strategy for each reserve will continue to be implemented, and FAFT and other fire trails progressively upgraded and maintained.

Local brigades will be engaged in familiarisation days and with planned burns, and neighbours will be engaged to foster an appreciation of the World Heritage property and reduce the risks of unplanned ignitions.

Operational response strategies will be addressed in the BFMC Plan of Operations through the development of the World Heritage Pre-Incident Plan.

The key Bush Fire Risk Management Plan Objectives and Treatment Strategies for the Ramsar Site are listed in Table 8.

1.9 Bulahdelah / Markwell

Risk Profile Bulahdelah / Markwell

The Mid Coast Bush Fire Management Committee (BFMC) has assessed the risk to residential, special fire protection (schools, health facilities, childcare etc.), economic, environmental and cultural assets and has identified Bulahdelah as a Focus Area.

This area also includes the locality of Markwell. The area has a history of deliberate and accidental bush fire ignition and there is potential for rapid fire development, particularly in the forested vegetation around the interface. Significant bush fires have impacted the Focus Area over the last 10 years, especially during 2013/14 and 2018/19 bush fire seasons.

A number of properties and economic assets, including tourism, commercial, agriculture that have been identified in the high risk category. Unemployment and residents requiring assistance to prepare for or relocate during emergencies are identified social and demographic factors that may make the community more vulnerable to the impacts of bush fire.

While the Pacific Highway passes East of Bulahdelah through the Focus Area, access and egress for residents is limited with Markwell road being the main access North into the valley and minor paved and unpaved roads extending into the surrounding hills and more remote forested areas of the Focus Area.

Bush fire is a key threatening process for many environmental assets. There is a risk that a high severity bush fire event in this area would cause serious damage or irreversible loss of regionally significant habitat for the Koala (*Phascolarctos cinereus*). There is also a risk that a bush fire could negatively impact eight Threatened Ecological Communities, thirty six species of threatened fauna, fourteen species of threatened flora including two critically Endangered species Native Guava *Rhodomyrtus psidioides* and Scrub Turpentine *Rhodamnia rubescens*) and the wetland ecosystems which occur along low lying areas adjacent to the Myall and Crawford rivers.

There is a risk that bush fires could harm the cultural value of the forty five Aboriginal sites and seven historic sites within this area.

There is a risk that bush fires, fire suppression operations and hazard reduction strategies could negatively impact two Save our Species (SoS) program sites and cause negative outcomes for threatened species conservation.

A key BFMC objective in Bulahdelah / Markwell is to improve Community Preparedness. In particular, the maintenance of private property Asset Protection Zones & the preparation of Bush Fire Survival Plans. This will be achieved through the implementation of activities such as local bush fire workshops and street meetings and the provision of resources such as bushfire advertising campaigns that aim to increase risk awareness, planning, preparation and community resilience for bush fire.



Risk Profile Bulahdelah / Markwell (continued)

As identified in the Fuel Management Register, the BFMC will maintain Asset Protection Zones and implement prescribed burning hazard reductions to strategic fire protection.

The BFMC will address the high number of deliberate and accidental bush fire ignitions with specific strategies in the BFMC Ignition Prevention Plan.

To increase resilience within the Focus Area the BFMC will identify specific operational response strategies for the assets/ areas of concern. The BFMC fire access and fire trail network will be reviewed and maintained.

The key Bush Fire Risk Management Plan Objectives and Treatment Strategies for Bulahdelah / Markwell are listed in Table 9.

1.10 Tea Gardens / Pindimar

Risk Profile Tea Gardens / Pindimar

The Mid Coast Bush Fire Management Committee (BFMC) has assessed the risk to residential, special fire protection (schools, health facilities, childcare and tourist accommodation), economic, environmental and cultural assets and has identified Tea Gardens / Pindimar as a Focus Area.

The area has a number of localities with isolated and rural properties and also increased numbers of tourists and transient population during summer and significant potential for rapid fire development, particularly from the adjacent forested vegetation. The last significant bush fires were in 2007 and 2009.

A number of residential homes, properties and special fire protection assets have been identified in the high and highest risk category. There are also economic assets (tourism and commercial) in the high risk category. Social and demographic factors contributing to the community's vulnerability to the impacts of bush fire include seasonal tourism, aged population and numbers of unoccupied dwellings/ absentee landowners.

Access and egress for residents is limited with single road access to of many localities, Pindimar Road and Myall Way being the main access to the area from the Pacific Highway which is located to the west of the Focus Area.

Bush fire is a key threatening process for many environmental assets. There is a risk that a high severity bush fire event in this area would cause serious damage or irreversible loss of habitat for the Koala (*Phascolarctos cinereus*), the critically endangered Beach Stone-curlew (*Esacus magnrostris*) and the internationally significant Myall Lakes Ramsar site. There is also a risk that a bush fire could negatively impact fourteen Threatened Ecological Communities, fiflty seven species of threatened fauna, eight species of threatened flora, coastal wetland ecosystems and the cultural value of the fifty six Aboriginal sites and sixteen historic heritage sites that been identified within this Focus Area.

There is a risk that bush fires, fire suppression operations and hazard reduction strategies could negatively impact eleven Save our Species (SoS) program sites and cause negative outcomes for threatened species conservation.

A key BFMC objective in Tea Gardens / Pindimar is to improve Community Preparedness. In particular, the maintenance of private property Asset Protection Zones & the preparation of Bush Fire Survival Plans. This will be achieved through the provision of resources such as targeted advertisement campaigns and signage and the implementation of programs such as get ready weekend and property assessments that aim to increase risk awareness, planning, preparation and community resilience for bush fire.



Risk Profile Tea Gardens / Pindimar (continued)

As identified in the Fuel Management Register, the BFMC will maintain Asset Protection Zones, manage linear fire breaks and implement a number of hazard reduction burns to manage Strategic Fire Advantage Zones.

The BFMC will address the high number of deliberate and accidental bush fire ignitions with specific strategies in the BFMC Ignition Prevention Plan. To increase resilience within the Focus Area the BFMC will identify specific operational response strategies for the assets/ areas of concern. The BFMC fire access and fire trail network will be reviewed and maintained.

The key Bush Fire Risk Management Plan Objectives and Treatment Strategies for Tea Gardens / Pindimar are listed in Table 10.

1.11 Werrikimbe NP Environmental Focus Area

Risk Profile Werrikimbe NP Environmental Focus Area

The Mid Coast Bush Fire Management Committee (BFMC) has assessed the risk to residential, special fire protection (schools, health facilities, childcare etc.), economic, environmental and cultural assets and has identified Werrikimbe as a Focus Area.

Within the BFMC area, Barrington Tops and Werrikimbe National Parks are listed on the Gondwana rainforests of Australia World Heritage list. The Gondwana Rainforests of Australia was inscribed on the World Heritage List in 1986, and includes the most extensive areas of subtropical rainforest in the world, large areas of warm temperate rainforest and nearly all of the Antarctic beech cool temperate rainforest. Few places on earth contain so many plants and animals which remain relatively unchanged from their ancestors in the fossil record.

The Gondwana Rainforests of Australia is a serial property comprising the major remaining areas of rainforest in southeast Queensland and northeast New South Wales. It represents outstanding examples of major stages of the Earth's evolutionary history, ongoing geological and biological processes, and exceptional biological diversity. A wide range of plant and animal lineages and communities with ancient origins in Gondwana, many of which are restricted largely or entirely to the Gondwana Rainforests, survive in this collection of reserves. The Gondwana Rainforests also provides the principal habitat for many threatened species of plants and animals.

All World Heritage properties in Australia are 'matters of national environmental significance' protected and managed under national legislation, the *Environment Protection and Biodiversity Conservation Act 1999*. By law, any action that has, will have or is likely to have a significant impact on the World Heritage values of a World Heritage property must be referred to the responsible Minister for consideration. Importantly, this Act also aims to protect matters of national environmental significance, such as World Heritage properties, from impacts even if they originate outside the property. The World Heritage properties are potentially vulnerable to inappropriate fire regimes including unplanned and intense bush fire events.

Bush fire is a key threatening process for many environmental assets.

A key BFMC objective in Werrikimbe is to implement an integrated approach encompassing fuel management, ignition management, community preparedness and response treatments.

Fuel management strategies for the focus area include investigating opportunities for prescribed burning hazard reductions to achieve strategic fire protection and land and biodiversity management. Trails within the Fire Access and Fire Trail Plan and other roads/ tracks will be progressively upgraded and maintained.

Local brigades will be engaged in familiarisation days and with planned burns, and neighbours will be engaged to foster an appreciation of the World Heritage property and reduce the risks of unplanned ignitions.

Operational response strategies will be addressed in the BFMC Plan of Operations through the development of the World Heritage Pre-Incident Plan.

1.12 Barrington Tops NP - Environmental Focus Area

Risk Profile Barrington Tops NP - Environmental Focus Area

The Mid Coast Bush Fire Management Committee (BFMC) has assessed the risk to residential, special fire protection (schools, health facilities, childcare etc.), economic, environmental and cultural assets and has identified the Gondwana Rainforests World Heritage property as a Focus Area.

Within the BFMC area, Barrington Tops and Werrikimbe National Parks include Gondwana Rainforests World Heritage. The Gondwana Rainforests of Australia was inscribed on the World Heritage List in 1986, and includes the most extensive areas of subtropical rainforest in the world, large areas of warm temperate rainforest and nearly all of the Antarctic beech cool temperate rainforest. Few places on earth contain so many plants and animals which remain relatively unchanged from their ancestors in the fossil record.

The Gondwana Rainforests of Australia is a serial property comprising the major remaining areas of rainforest in southeast Queensland and northeast New South Wales. It represents outstanding examples of major stages of the Earth's evolutionary history, ongoing geological and biological processes, and exceptional biological diversity. A wide range of plant and animal lineages and communities with ancient origins in Gondwana, many of which are restricted largely or entirely to the Gondwana Rainforests, survive in this collection of reserves.

The Gondwana Rainforests also provides the principal habitat for many threatened species of plants and animals. All World Heritage properties in Australia are 'matters of national environmental significance' protected and managed under national legislation, the *Environment Protection and Biodiversity Conservation Act 1999*. By law, any action that has, will have or is likely to have a significant impact on the World Heritage values of a World Heritage property must be referred to the responsible Minister for consideration. Importantly, this Act also aims to protect matters of national environmental significance, such as World Heritage properties, from impacts even if they originate outside the property.

The World Heritage properties are potentially vulnerable to inappropriate fire regimes including unplanned and intense bush fire events. Bush Fire is a key threatening process for many environmental assets.

Fire events, suppression operations and/or hazard reduction activities could negatively impact the structure and composition of seven Threatened Ecological Communities as well as the habitat and lifestyle processes for threatened fauna and flora, including the critically endangered Native Guava, *Rhodomyrtus psidioies* and Scrub Turpentine, *Rhodamnia rubescens*. One site declared an Asset of Intergenerational Significance (AIS) for the Rufus Scrub-bird, *Atrrichornis rufescens* (Vulnerable) and regionally significant habitat for Koalas, *Phascolarctos cinereus* also exist in the Barrington Tops NP Environmental Focus Area.



Risk Profile Barrington Tops NP - Environmental Focus Area (continued)

There is potential for additional AIS declarations in the future and NPWS or the AIS website should be referenced for updates during the life of the risk plan.

A key BFMC objective in the Barrington Tops Environmental Focus Area is to implement an integrated approach encompassing fuel management, ignition management, community preparedness and response treatments.

Fire management strategies for the focus area include prescribed burning hazard reductions to achieve strategic fire protection and land and biodiversity management. Trails within the Fire Access and Fire Trail Plan and other roads/ tracks will be progressively upgraded and maintained.

Local brigades will be engaged in familiarisation days and with planned burns, and neighbours will be engaged to foster an appreciation of the World Heritage property and reduce the risks of unplanned ignitions.

Operational response strategies will be addressed in the BFMC Plan of Operations through the development of the World Heritage Pre-Incident Plan.
